




Department Overview

Maintenance Overview


- Maintenance has about 740 employes
- Maintain about 25,000 lane miles of roadway
- Have about 4,700 pieces of equipment
- Maintain facilities at over 220 occupied locations statewide



MDT Statewide Maintenance Overview



Budget

- The SFY 2024 Maintenance budget is about \$169.7 million
 - 9% Federal Funds
 - 91% Highway State Special Revenue Account (State gas tax)
- The \$169.7 million is broken down into the following categories;
 - \$62.5 million in Personal Services
 - \$106.5 million in Operations and Equipment

- Communications Bureau
- Equipment Bureau
- Facilities Bureau
- Systems and Operations Bureau
- Statewide Maintenance Operations
- Disaster and Emergency Services


Land Radio Network




- 10 Communication Technicians responsible for:
 - Over 100 radio towers
 - More than 4000 radios statewide
 - 350 cell phones
 - 900 cellular-enabled devices



- Fabrication at Helena HQ
 - Five fabricators build snowplow trucks year around
 - Complete 3-4 trucks every 5-6 weeks.
 - The bureau purchases the cab and chassis, dump box, sander, front plow, wing plow(s), light package, and hydraulic controls.
 - The fabricators assemble the components and produce a snowplow to our specifications.
 - Estimated cost saving are approximately \$100,000 per truck



- MDT averaged 30-40 snowplow hits each winter since 2016
- Concern for driver and traveling public safety






- MDT owns and maintains a total of 1,170





Job Profiles and Career Ladder completed—July 2020




Completed the hiring process for the 6 Dispatcher positions and completed training—September/October 2020

Went live September 2021


